2. Mayor Rogero to Deliver Her Second Inaugural Address Saturday

The public is invited to attend the Inauguration of Mayor Madeline Rogero and the swearing-in of four City Council members and the City Judge at 10:30 a.m. Saturday, Dec. 19, 2015, in the Main Assembly Room, City County Building, 400 Main Street.

Taking oaths of office will be Knoxville Mayor Madeline Rogero; City Council member George Wallace, At Large Seat A; City Council member Marshall Stair, At Large Seat B; City Council member Finbarr Saunders, At Large Seat C; City Council member Mark Campen, 5th District; and City Judge John R. Rosson Jr.

During Saturday's ceremony, Mayor Rogero will deliver her second inaugural address. She, the four City Council members and Judge Rosson were all incumbents re-elected in the fall 2015 elections.

A specially called City Council meeting will follow at 11:15 a.m. in the Small Assembly Room for the selection of a Vice Mayor, Beer Board chair and Council representative on the Knoxville Transportation Authority board.

Free parking is available in the Main Street, Dwight Kessel and City County Building garages. A security checkpoint will be in place at the entrances to the City County Building garage, and all guests will be required to go through a security checkpoint to enter the City County Building.

Accessible parking is available at the City County Building. 3. 22 Neighborhoods Now Have an Emergency Contact Volunteer

The Knoxville Knox County Emergency Management Agency (KEMA) and the Office of Neighborhoods are looking for a volunteer in each of Knoxville's neighborhoods to serve as an emergency contact to ensure timely and coordinated response in the event of a widespread emergency.

Kudos to the following 22 neighborhoods which have already responded to the call for emergency contacts: Anteelah Trail, Brittany Place, Deane Hill, Eastport/Lee Williams, Edgewood Park, Fairmont-Emoriland, Fire Street Lofts, Fountain City, Glenview, Historic Fourth and Gill, Island Home Park, Murray Dr. / Wilkerson Rd., Montgomery Village, Moss Creek, Old North Knoxville, The Holston, The Village at Bearden, Timbercrest, View Park, West Haven, West Hills, and West View.

As a volunteer emergency neighborhood point person, you must be able and willing to drive or walk your neighborhood, street by street, to assess the level of emergency in your particular community. You can then communicate the status of your neighborhood using a special phone number or other emergency communications method.

Contact persons will meet annually to learn about potential emergencies, meet key emergency agency personnel, and learn about disaster assessment.

4. Grant Funding Available for City Neighborhood Groups

The City of Knoxville is allocating up to \$43,000 for the Neighborhood Small Grants Program (NSGP) in 2016.

Grant funds can be used for projects and programs developed by resident-led, resident-controlled neighborhood associations, tenant associations, homeowners associations, and neighborhood watch groups that serve neighborhoods inside city limits. Start-up neighborhood groups may also apply.

Groups wishing to apply must send a representative to either one of two mandatory pre-application workshops scheduled for 5:30 p.m. Thursday, January 14, and 5:30 p.m. Wednesday, January 20, at the Cansler Family YMCA, 616 Jessamine Street.

Applications are due March 14, and awards will be announced in May for projects starting in July.

Neighborhood groups can apply for grants ranging from \$500 to \$3,000. To enhance the impact of the city's funding, grants must be matched with donations of goods and services, volunteer labor and other financial support for the project.

Please note that many questions can be answered by reading the guidelines and looking over the application. Both the guidelines and application will be reviewed at the January workshops.

5. TPO Meets Wednesday

The executive board of the Knoxville Regional Transportation Planning Organization meets at 9 a.m. tomorrow --- Wednesday, Dec. 16 --- in the Small Assembly Room of the City County Building.

Eight major items are on the agenda, including the annual listing of all transportation related projects in which federal funds were obligated in the past fiscal year. For details on this and other agenda items, [see the agenda](#).

TPO coordinates a comprehensive, multimodal transportation planning process for the Knoxville Urban Area, which includes Knox County and the urbanized areas of five adjoining counties and several towns.

6. Bearden Compromise on Council Agenda Thursday

Knoxville City Council meets this coming Thursday, Dec. 17, in lieu of the regularly scheduled meeting on Dec. 22.

The very short agenda includes an appeal by the Bearden Council of the Metropolitan Planning Commission's decision to grant a use-on-review for a new building at 3816 Sutherland Avenue, where El Charro restaurant will be located.

Bearden Council had opposed the use-on-review on the grounds that the building setback (toward the rear of the lot, with parking next to the street) is incompatible with the Bearden Village Opportunities Plan. Bearden Council has been particularly vigilant in urging developers to conform to the design guidelines contained in the plan.

However, at a meeting on Dec. 1, all parties agreed to a compromise, whereby Bearden Council agreed to drop its appeal following an agreement by the restaurant to enhance the site with a 12-foot-wide, heavily landscaped strip of land between the parking lot and the public right-of-way.

7. Tour de Lights Happening this Friday

Join hundreds of other bicyclists of all ages this Friday, December 18, for the 9th annual Tour de Lights bike parade.

Participants will leave Market Square at 7 p.m. and embark as a group on a bike ride through Fourth and Gill and Old North Knoxville neighborhoods.

Tour de Lights is a free, family-friendly event. The route is approximately five miles long and will take less than an hour to complete. The pace will be casual. Everyone is encouraged to dress up and decorate their bikes.

If you would like to enter the costume contest, be sure to arrive early as the judging will take place between 6 p.m. and 7 p.m. There will be prizes for best costume (adult and child), best bicycle and/or trailer, best helmet, best group with theme, and best all around. The Mast General Store and Three Rivers Market will also provide hot cocoa and treats.

9. Fourth & Gill to Host Jan. 7 Community Meeting on Pain Clinic

The Fourth & Gill Neighborhood Association will hold a North Knoxville community meeting at 7 p.m. Thursday, Jan. 7, at Central United Methodist Church, 201 E. Third Avenue, to discuss a new pain clinic planned for the old labor union building at 1124 N. Broadway.

“The clinic will provide treatment for spine and neck pain and will provide medically assisted treatment for opioid addiction,” according to a notice issued by the neighborhood organization. “The clinic will be run by Dr. (Michael) Chavin, who currently operates a similar clinic in Morristown. Dr. Chavin recently moved to Knoxville and will close his Morristown clinic to work exclusively at his new Knoxville clinic.

“To provide the North Knoxville community with a better understanding of his clinic and his services, Dr. Chavin recently reached out to Fourth & Gill President Liz Upchurch asking to schedule a community meeting.

“The meeting will provide an opportunity to hear Dr. Chavin describe his practice and the patients he serves, and we will have a Q&A session following his presentation,” the notice concludes.

10. City Schedules Jan. 12 Meeting on Use of Federal Funds

The City of Knoxville’s Community Development Department will hold a public meeting at 5:30 p.m. Tuesday, Jan. 12, 2016, at O’Connor Senior Center, 611 Winona St.

The purpose of the meeting is to gather information and public input as the department develops its Annual Action Plan Update for the proposed use of federal funds for the program year 2016-2017.

Each year, the department utilizes Community Development Block Grant (CDBG), HOME Investment Partnership Act, and Emergency Solutions Grant (ESG) funds. All three funds are administered by the U.S. Dept. of Housing and Urban Development (HUD).

At this meeting, Community Development staff will review priorities and strategies from the 2015-2019 Five Year Consolidated Plan and constraints that impact how HUD funds are allocated; get specific feedback from neighborhood, business, and non-profit housing and homeless services partners on opportunities/challenges; and take comments from other citizens.
