If you are prescribed a 90-day prescription for maintenance medications, you can fill your prescription at retail pharmacies or through mail service.

Getting started with Walmart Home Delivery Pharmacy

Please reach out to your prescriber and update your mail order pharmacy provider as Walmart. Before prescriptions can be filled through Walmart Home Delivery, a profile needs to be created through one of the following options.

- ✓ **Phone:** call **1-855-922-7799** and follow the prompts for medications delivered to your home.
- ✓ **Mail:** send a completed order form to **1025 W. Trinity Mills, Carrollton, TX 75006**. Blank forms are available on the Capital Rx Member Portal.
- ✓ **E-Mail:** email a completed order form to **WMSRX@walmart.com**.

E-prescribe: Have your doctor e-prescribe to **Walmart Pharmacy Mail Order 2625**.



Fax: Have your doctor fax your prescription to **1-800-406-8976**.



Mail: Mail us your prescription and completed order form to **1025 W. Trinity Mills, Carrollton TX, 75006**.

Prior Authorization/Step Therapy/Quantity Limit

In order to ensure safe and appropriate use of certain medications, your prescription benefit program may have prior authorization, step therapy, and/or quantity limits for certain medications.

- **Prior authorization** requires you and your physician to obtain approval from Capital Rx prior to medication being dispensed.
- **Step therapy** is when your prescription benefit requires you to try another medication (usually a generic) prior to starting the medication your physician prescribed (usually a brand).
- **Quantity limits** only allow you to receive up to a maximum dosage or quantity for certain medications, based on clinically-approved prescribing guidelines.

Call customer service at **1-855-922-7799** to determine if your medication(s) are subject to prior authorization, step therapy, and/or quantity limit requirements.






Specialty Medications

If you are prescribed a specialty medications, you can fill your prescription at your preferred specialty pharmacy.

Log into the Capital Rx Member Portal and use the pharmacy locator tool to see what specialty pharmacies are convenient for you.
