V. Member Advocacy and Information – (Karen Lowe) – Healthcare Accessibility

- Healthcare matters because everyone will need a doctor at some point.
- Doctors are in "practice," however they do not know everything.
- It is the law that healthcare is accessible, not necessarily affordable.
- The Rehabilitation Act of 1973, Section 504 makes sure that doctor's offices, clinics, and medical equipment are accessible to people with a disability. (various sources)
- Resources in TN: Disability Rights TN(DRT), Tennessee Disability Pathfinder
- The average annual cost for a person with a disability (\$13,492) is significantly higher than for a person without a disability (\$2,835) including out of pocket costs which are more than twice as high (\$1053 v. \$486). The Affordable Care Act has helped ease the affordability issue with 21.2% of people with disabilities, down from 26.9%. source: https://nationaldisabilities/
- A study done in partnership with NDI, UTK, Stony Brook University, and the Oxford Institute of
 Population Aging, estimated that a household containing an adult with a disability that limits their ability
 to work requires an average of 28% more income (or an additional \$17,690 a year) to obtain the same
 standard of living as a similar household without a member with a disability. There are also direct costs

- Being a Self-Advocate:
 - o Believe in yourself (you know you the best)
 - o Prepare (write things down, including what you are wanting to accomplish)

- o Communicate effectively (politeness, kindness, stay calm, listen)
- o Get the facts (ask for things in writing so you can go over it with someone you trust)
- o Keep your own records
- o Follow up
- You have the right to leave if you are not being listened to or feel uncomfortable, I have done it.
- You can tell the doctor that you are not doing tests again if they are just going to share the same information that is already done, I have done this too, as an extra test costing more money to not learn anything new is not good).
- Assertive Vs. Aggressive
 - o Assertive is being forthright with your wants and needs while still considering the rights, needs, and wants of others.
 - O Aggressive is doing what is in your own best interest without regard for the rights, needs, and feelings or desires of others.
- Sometimes it is easier to advocate for others, but you also have to speak up for yourself.
