


VARIANCE REQUIREMENTS City of Knoxville Zoning Ordinance Article 16.3 The City of Knoxville Board of Zoning Appeals shall have the power and authority to grant variances from terms of this ordinance according to the procedure and under the restrictions set out in this section. The purpose of the variance is to modify the strict application of the specific requirements of this ordinance in the case of exceptionally irregular, narrow, shallow or steep lots, or other exceptional physical conditions, whereby such strict application would result in practical difficulty or unnecessary hardship which would deprive an owner of the reasonable use of his land. The variance shall be used only where necessary to overcome some obstacle which is preventing an owner from using his property as the zoning ordinance intended. DESCRIPTION OF APPEAL Describe your project and why you need variances. Owner would like to record a 1 lot subdivision of this parcel. The current property alignment has a front width of 44.31 feet. This existing lot will need a variance from the minimum lot width of 75 feet in order to be recorded.


