1. Lonsdale Hosts “Eat, Play, Live” Community Day

Lonsdale United for Change --- the resident-led, resident-controlled neighborhood organization in Lonsdale --- is partnering with Knox County Health Department, Children’s Hospital and others to conduct the Eat, Play, Live Lonsdale Community Day this Saturday, April 27, in Lonsdale Park and at Lonsdale Recreation Center.

Activities begin at 10:00 am. Projects planned for the day include the installation of Lonsdale neighborhood signs, the planting of trees in the park and at the schools, and the establishing of community gardens. Activities will be provided by East Tennessee Children’s Hospital at the Lonsdale Recreation Center for ages 5-12.

Lunch will be provided, and Lonsdale United for Change will be conducting a membership drive.

“This will be a great day to bring together the residents of Lonsdale --- a community which is learning to celebrate its great diversity,” noted Steve Ritter, president of Lonsdale United for Change. Activities will conclude at 2:00 pm.

2. May 2 Meeting to Explore Future Uses for Rule High School

Several months ago, Knox County solicited expressions of interest from developers who might wish to purchase and redevelop the Rule High School property located on the northern edge of the Beaumont neighborhood and the southern edge of the Lonsdale neighborhood.

There were no takers.

Now the Knox County School Board has asked the Community Design Center to review the current conditions at Rule High and suggest possible future adaptive uses. CDC’s work on this --- along with similar work still underway on the future of Old Knoxville High --- is funded by the city’s Community Development Department.

As part of the review process, CDC will hold a public meeting next Thursday evening to provide information on the facility today and to gather input on what citizens would and would

not like to see developed on the site, which has a commanding view of downtown Knoxville and the mountains.

The meeting begins with refreshments at 6 p.m. at the L.T. Ross Building, 2247 Western Avenue. From Western, turn up Major Street and park in the rear parking lot. Enter through the double glass doors and walk straight back to the community room. The presentation and public input portion of meeting starts at 6:30 p.m. and ends at 8 p.m.

3. Mayor Appoints Four, Reappoints One to Advisory Council

Mayor Madeline Rogero has appointed five community leaders to serve on the Neighborhood Advisory Council (NAC) over the next three years.

A resolution expressing support for the appointments is on City Council's agenda for next Tuesday, April 30. NAC advises the Administration on neighborhood-related issues and concerns.

Four of the appointments are new:

**** Terry Caruthers** --- a member of the executive board of Colonial Village Neighborhood Association and one of CVNA's representatives to the South Knoxville Neighborhood and Business Coalition --- will fill Seat 1-B.

**** Donna Downen**, who is active in the Glenview Homeowners' Association, was named to Seat 3-A.

**** Bill Hutton**, an active member of Oakwood Lincoln Park Neighborhood Association, was appointed to Seat 5-B.

**** Bobby Braly**, vice president of Parkridge Community Organization, will occupy one of three at-large seats.

These are three-year appointments. The four new NAC members replace longtime members Whitney Stanley, Jody Mullins, Barbara Armstead and Polly Doka, whose terms expired.

In addition, the Mayor reappointed **Lauren Rider**, president of Old North Knoxville, Inc., to a full three-year term in Seat 4-A.

NAC consists of 15 members --- two from each City Council district and three at large. The group meets from 4:30 p.m. until 6 p.m. on the second Wednesday of each month (except July and December) at the L.T. Ross Building, 2247 Western Avenue. 4. Sign Task Force Seeks Views on Draft Ordinance

A City Council Sign Task Force is wrapping up its effort to rewrite the ordinance governing signs in the City of Knoxville, and as one final step the task force is holding a public input meeting next week.

The meeting will start at 5:30 p.m. Wednesday, May 1, in the Mary Starr Auditorium of the John T. O'Connor Senior Center, 611 Winona. For those coming from outside the immediate area, take I-40 to the Broadway/Hall of Fame exit. Turn down Hall of Fame Drive, take a left on Fifth Avenue or Magnolia, and then a left on Winona. The parking lot is located between the senior center and the Cansler Family YMCA.

Each person who wishes to address the task force will have a few minutes to state their views and concerns.

A recent email from Scenic Knoxville, a nonprofit advocacy organization (<http://www.scenicknoxville.org/>), highlighted the likely focus of debate when the Ordinance goes before City Council.

"The final proposal will result in noticeable improvements to the appearance of our City over time," stated Scenic Knoxville president Joyce Feld in a recent email. "One area of major disagreement, however, is the issue of maximum allowable sign heights for individual businesses. Several members of the committee [the task force] want to continue to allow very tall, lighted, on-premise business signs (35' to 50')."

5. MPC Prepares for Public Input on Central and East Sector Plans

Metropolitan Planning Commission (MPC) has embarked on a multi-month effort to gather public input for upcoming updates to the Central City and East City Sector Plans.

MPC staff in early April met with neighborhood leaders in the two sectors, and they are now scheduling meetings in individual neighborhoods to go over the planning process and seek input on challenges, concerns and goals for physical improvements and development.

Larger public meetings will be announced later this spring. In the meantime, residents of the East and Central sectors can provide their input via a detailed survey that will be available over the next two weeks. Also, MPC staff has prepared draft background reports as a precursor to drafting the new sector plans.

Here is some background on Sector Plans.

The City of Knoxville and Knox County are divided into 12 planning sectors. The East City Sector includes but is not limited to the Alice Bell / Spring Hill, Burlington, Chilhowee Park, Cold Springs, Edgewood Park, Fairmont-Emoriland, Holston Hills, Michael-Meadowview, North Hills, and Whittle Springs neighborhoods.

The Central City sector includes but is not limited to downtown and the University of Tennessee as well as the Beaumont, Belle Morris, Five Points, Fort Sanders, Fourth & Gill, Lonsdale, Marble City, Mechanicsville, Morningside, Oakwood Lincoln Park, Old North Knoxville, Parkridge, Sutherland Heights, West Haven, and West View neighborhoods.

The focus of the sector plan is physical development, and therefore land use, transportation and community facilities are the key elements. Sector plans are important to neighborhoods because:

*** They contain goals, policies and proposals to guide the sector's growth over a 15-year period and a 5-year plan for proposed capital improvements.

*** MPC uses the plan on a month-to-month basis to guide zoning and subdivision decisions.

6. Mayor Proposes Budget with No Tax Increase

Mayor Madeline Rogero today proposed a budget for the 2013-14 fiscal year with no property tax increase and significant new investments in City infrastructure.

The net proposed City budget is \$295.8 million, with the General Fund making up about \$183.2 million. That amounts to a 1.45 percent increase in the General Fund from the adopted 2012-13 budget.

"This budget is not ultimately about finances. It's really about a vision for our city – how we will grow, what services we will provide, and what quality of life we all will enjoy," Mayor Rogero said during her address at Ijams Nature Center. "The budget that I have presented

today is balanced and affordable. It meets basic needs, and it positions us for greater opportunities.”

Among the new spending proposed in the budget are several capital items: \$15 million for a Public Works complex to replace the aging facilities on Loraine Street (design funding for this project was included in the 2012-13 budget); \$10 million for improvements to the Knoxville Zoo; \$5.2 million for demolition and improvements on property the state is conveying to the City at Lakeshore Park; and \$1.2 million to redress chronic flooding problems on Prosser Road.

These projects will be funded through the issuance of \$31.4 million in new debt. This is the first major City capital debt issue since 2004.

Budgeted personnel total for 2013-14 is 1,598 full-time positions and 33 part-time positions. Employee salaries, benefits and health care make up about 70 percent of the General Fund. The budget proposes a 2.5 percent salary increase for all City employees.

Other highlights in the proposed budget include:

- *** \$5.45 million for the City’s annual street paving program;
- *** \$1.8 million for sidewalks and crosswalks, including \$550,000 for new sidewalk construction (an increase of \$150,000);
- *** \$500,000 matching grant for an Advanced Traffic Management System, which lays the groundwork for better signal timing and traffic flow;
- *** \$600,000 in anti-blight funds to address chronic problem properties, acquire blighted properties and enforce the Demolition by Neglect ordinance;
- \$800,000 for KCDC’s continued redevelopment of the Walter P. Taylor Homes/Five Points area. The City has committed \$8 million to that area over 10 years;
- *** \$170,000 toward a regional public-private partnership to attract low-fare air service to McGhee Tyson Airport;
- *** \$100,000 to expand Community Schools in center city neighborhoods, in collaboration with the Great Schools Partnership and Knox County Schools;
- *** \$100,000 for the Downtown Improvements Fund (an increase of \$50,000), along with \$300,000 for the Magnolia Warehouse Redevelopment area and \$100,000 for projects in the Downtown North corridor;
- *** \$60,000 toward bicycle infrastructure improvements;
- *** \$1.5 million for an Automatic Vehicle Location system to increase efficiency of the City vehicle fleet;
- *** An alternative transportation coordinator in the Engineering Department, with expertise in engineering for pedestrians, cyclists and mass transit;
- *** A small-business coordinator in the Purchasing Department, to implement the City’s new small-business program.
