1. Knoxville, High Utility Bills Featured on National Public Radio

National Public Radio’s “All Things Considered” news show on March 14 featured a story about utility bill assistance and weatherization programs in Knoxville.

NPR producer Andrea Hsu visited Knoxville several weeks ago to hear about how Knoxville organizations such as the Knoxville-Knox County CAC and their partners are helping families that struggle to pay utility bills. [Hear the whole story here.](#)

Among the topics discussed was Knoxville’s participation in the [IBM Smarter Cities Challenge program](#), and the efforts now underway by a broad array of partners to promote weatherization as the preferred solution to high energy bills, gradually replacing assistance to those who are unable to afford their bills.

“We think the story will help highlight how proactive energy efficiency and weatherization programs can work hand-in-hand with energy assistance programs to empower families to lower their utility bills,” stated Erin Gill, the city’s sustainability coordinator.

2. ABSHNA, Others Offer “Candidates Meet and Greet” Opportunity

Alice Bell Spring Hill Neighborhood Association (ABSHNA) and partnering neighborhood organizations are sponsoring a “Candidate Meet and Greet” event from 6-8 p.m. this coming Monday, March 17, at New Harvest Park, 4775 New Harvest Lane off Washington Pike.

Other sponsoring groups are Fountain City Town Hall, North East Knox Preservation Association, North Hills Area Association, and Town Hall East.

County, State and Federal elections are on the calendar for this spring and fall, and there are quite a few positions on the ballots.

Locally, these include County Mayor, Sheriff, Knox County Trustee, four seats on Knox County Commission, five seats on the Knox County Board of Education. State offices on the ballot include Governor, State House, State Senate, and a variety of court judgeships and clerks. Lamar Alexander’s U.S. Senate seat and U.S. House of Representatives seats are also on the ballot.

Candidates for the Knox County races are set; the qualifying and withdrawal deadlines have passed. Candidate qualifying deadline for the State Primary Election is April 3.

Last day to register for the Knox County Primary is April 7, and the primary will be held on May 6. City voters are also county voters and can vote in these contests.

Last day to register for the County General Election and the State Primary is July 8, and Election Day (County General and State Primary) is August 7. The State General Election is November 4.

3. Awards Luncheon Features Youth, Networking, Honors

By all accounts, the stand-outs of last Saturday's Neighborhood Awards & Networking Luncheon were the high-school-age youth who not only participated in a round table discussion on neighborhoods but also reported on their tables' solutions for turning vacant spaces into vital places in a neighborhood.

The interactive session brought together neighborhood advocates, city officials and others who put their thoughts on paper. Through words and drawings, they communicated their favorite places and how the best features of those favorite places could be used to transform a street corner, a vacant lot, an alley or other under-used space for the benefit of the entire community.

Some 300 neighborhood advocates, city officials, volunteers and others participated in the entire event, including the students from the Austin East Magnet High School's Culinary Arts program, who provided lunch, and from the Mount Olive Music Academy, who played keyboard, violins and African drums.

Knoxville spoken word artist Black Atticus provided entertaining and thought-provoking poems about neighbors and community.

Betty Jo Mahan, president of the Inskip Community Association (Asociación de la Comunidad de Inskip), walked away with the Diana Conn Neighbor of the Year Award.

She shared the stage with other honorees nominated by their neighbors for their outstanding contribution to their communities. These were Bruce and Tracy Martin, Delrose Drive Neighborhood Watch; Calvin Chappelle, Parkridge Community Organization; Gerry Moll, Fourth and Gill Center (The Bird House); Kathy Hitchcox, South Woodlawn Neighborhood Association; and Travetta Johnson, Parkridge Community Organization.

Six neighborhood organizations received Neighborhood Achievement Awards for a rich variety of projects and community-building efforts: Alice Bell Spring Hill Neighborhood Association, Lakemoor Hills Homeowners Association, Lyons View Community Club, Parkridge Community Organization South Woodlawn Neighborhood Association, and

Western Heights Residents Association. Each will receive a \$75 check to be used for community building.

6. City to Sponsor Enrollment Event for Affordable Care Act

Mayor Madeline Rogero this week urged Knoxvilleans lacking health insurance to learn about their options, because March 31 is the deadline for enrollment under the Affordable Care Act.

In partnership with the nonprofit group Get Covered America, Mayor Rogero hosted an interfaith breakfast Tuesday morning for local ministers to encourage them to provide enrollment information and assistance to members of their congregations.

"For the first time, those who have been shut out of the health insurance system in the past have a new way of accessing quality, affordable options," Mayor Rogero said to more than 50 representatives of area churches. "Faith leaders like you share a vision of a moral responsibility to care for our nation's sick, our nation's children, and the overall health of our community."

The mayor also spoke Tuesday morning to a group of volunteer canvassers, who have been going door to door throughout Knoxville neighborhoods since October to raise awareness about the new health insurance marketplace set up under the ACA.

The City of Knoxville is sponsoring an enrollment event from 10 a.m. to 2 p.m. on Saturday, March 22, at Pellissippi State Technical Community College's Magnolia Campus, 1610 E. Magnolia Ave. Trained enrollers will be on hand to provide free assistance to people who want to apply for health coverage.

7. Take a Stand Against Bullying

In May of 2010, Ty Smalley was an 11-year-old kid from Perkins, Oklahoma, a student who “always had a big smile for everyone,” who loved to help others --- and who was small for his age.

After being bullied for over two years, Ty retaliated against the bully and was suspended from school. He then took his own life.

In response, students from the Upward Bound program at Oklahoma State University partnered with Ty’s parents, Kirk and Laura Smalley, to form a nonprofit called “Stand for the Silent” so they can share their story and work to educate others.

Kirk Smalley is the featured speaker next month at a Town Hall meeting sponsored by the Knoxville Police Department as it continues its “Take a Stand Against Bullying” campaign. Smalley’s presentation will be followed by a panel discussion.

The event occurs from 6-8 p.m. Thursday, April 17, in the auditorium of South College, West Campus, 400 Goody’s Lane, Knoxville TN 37922. This South College location is in deep West Knoxville, is visible from I-40, and is accessible from Parkside Drive near Parkside’s intersection with Lovell Road.
