### **3. Parkridge to Host Historic Tour of Homes This Sunday**

The Historic Parkridge Neighborhood will be hosting a Prohibition-Era Home Tour on Sunday, October 26, 2014, from 1-5 p.m.

The tour will include seven houses and three homes in the Park Place condominiums. The homes will span the era from 1907 until the end of prohibition in 1933, and are good examples of the ongoing revitalization of the neighborhood. In addition, ticket holders can take a walking tour of 20 homes that will not be open to the public. The walking tour will focus on the history of the homes and their former occupants.

As noted on the Parkridge website, the neighborhood is less than two miles from downtown Knoxville. Parkridge is known for having the largest concentration of George Barber homes in the nation.

Tickets are \$10 per person. Children under 12 are admitted free. Parking is available at the Ashley Nicole Park, 620 Winona Street. ## **6. Citizens Can Testify on Blighted Properties**

Twenty-one properties are on the agenda for the next Public Officer Hearing at 9:30 a.m. Friday, Oct 31, in the Small Assembly Room of the City County Building.

If any of these properties are in your neighborhood, consider attending the meeting to submit testimony about the impact of the property on the neighborhood.

The properties that have been approved to be heard for repair/demolition orders are: 1510 Brown Avenue, 314/322 West Church Avenue (confirmation of emergency repair only order), 5918 Clinton Highway, 1117 Cornelia Street, 1510 Delaware Avenue, 4126 Garnet Drive, 4130 Garnet Drive, 434 Hiawassee Avenue (confirmation of emergency repair only order), 471 Hiawassee Avenue, 2748 Lay Avenue, 921 Lynn Avenue, 225 East Quincy Avenue (confirmation of emergency repair only order), 2621 Scottish Pike, 4714 Sevierville Pike (confirmation of emergency repair only order), 2823 Sunset Avenue, 535 Sunshine Circle, 2246 Virginia Avenue, 406 West Street, 716 Washburn Road.

At this meeting, the Public Officer --- David Brace, director of the Public Service Department -- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then will decide whether to issue an order requiring that the violations be addressed in a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner. A property owner may appeal the Public Officer's decision to the Better Building Board and, ultimately, to Chancery Court.

## **7. Leaf Collection Season Begins Soon**

The City of Knoxville's Public Service Department will soon convert its brush pickup trucks to leaf pickup mode for its annual leaf season, which runs from Nov. 1 to Feb. 1 of each year.

Leaves should be raked to the edge of your yard in one continuous row within five feet of the street. Do not block storm drains and drainage ditches. Also, please do not rake leaves into the street: They are a safety hazard, and they get crushed and scattered by passing cars. Moreover, after you rake leaves to the street, it may be two to three weeks before the leaf truck comes through your neighborhood.

The City will not pick up mixed piles of leaves, brush, and other refuse because the leaf collection equipment is designed to vacuum up leaves only and can be damaged by brush.

Leaf collection schedules vary during the season based on tree density, age and type; weather events; topography; and several other factors. Schedules are adjusted by managers in the field on a weekly basis.

Knoxville residents can find out when their leaves will be picked up by accessing the City's website at [www.cityofknoxville.org](http://www.cityofknoxville.org) and clicking on the "Leaf Pickup Schedule" icon on the right side of the page. (This icon will replace the Brush Pickup icon by Nov. 1.)

Schedules are updated on a weekly basis and dated the Monday of the week when City crews will be in those neighborhoods. Further information is also available by calling 311.

Brush collection will continue during November, December and January, but this is done on a limited basis, as resources are available.

The meetings will be held 6-7 p.m. Monday, Dec. 8, at Cumberland Estates Recreation Center, 4529 Silver Hill Drive, and 6-7 p.m. Thursday, Dec. 11, at Middlebrook Pike United Methodist Church, 7234 Middlebrook Pike.

## **9. Public Hearing Scheduled on Tennova's Proposed Hospital Site**

If you wish to express your opinion about the need for Tennova's proposed new hospital on Middlebrook Pike, now is the time.

Tennova has filed a Certificate of Need application with the state's Health Services and Development Agency, which has scheduled a public meeting on the matter at 6 p.m. Monday, Oct. 27, in the Small Assembly Room in the City County Building.

To voice their opinions, citizens may testify at this meeting, email [Mark.Farber@tn.gov](mailto:Mark.Farber@tn.gov), or send letters to Health Services and Development Agency, Andrew Jackson, 9th Floor, 502 Deaderick Street, Nashville, TN 37243.

Finally, the agency has scheduled its final Tennova hearing in Nashville on Nov. 19. Letters and emails need to be received before the Nov. 19 hearing, at which time a decision will be made.

Tennova's Certificate of Need Application is not posted online. However, if you would like to view the application, email [Mark.Farber@tn.gov](mailto:Mark.Farber@tn.gov), and he will send you an electronic version.

The Tennessee Health Service and Development Agency reviews three questions to make its decision: Is there a need? Is the project economically feasible? How does it contribute to the "orderly development of health care"?
