3. Groups Partner for “Day of Remembrance” Neighborhood Cleanups

Keep Knoxville Beautiful --- along with AmeriCorps members from CAC and Emerald Youth Foundation --- are hosting an MLK Day of Service in respect and remembrance of Dr. Martin Luther King Jr.

Neighborhood cleanups will be performed from 9 a.m. to 12 p.m. Saturday, Jan. 17, in the West View neighborhood and in East Knoxville’s Morningside Park. Others are invited to join in.

Volunteers can meet at the pavilions at West View Park off Keith Avenue and Western or at the Alex Haley statue at Morningside Park off Dandridge. To sign up as an individual, a family or a team at either location, please visit www.VolunteerKnoxville.org and enter the keyword "MLK Day of Service".

The goal is to clear over 40 streets, two parks, two neighborhoods, one school and one cemetery of roadside litter and debris. Keep Knoxville Beautiful will provide trash bags, gloves, litter pickers, and safety vests for all participants and will offer hot cocoa for all braving the January cold. A free hot lunch will also be provided after the cleanup.

4. City Announces Martin Luther King Holiday Schedule

City offices will be closed on Monday, Jan. 19, in observance of Martin Luther King, Jr. Day.

Waste Connections, the city’s household garbage and recycling hauler, will also be closed, so there will be no garbage or recycling collection that day. Trash and recycling pick-up will be one day behind schedule next week. Monday pickup will be on Tuesday, Tuesday pick-up will be on Wednesday, and so on. Residents who normally have pick-up on Friday will be serviced on Saturday.

Downtown trash and recycling will run on the regular schedule January 19. The city's recycling centers will be open for recycling use, but the Goodwill attendant will not be available for household goods donations.

The city's Solid Waste Management Facility located at 1033 Elm Street will be closed on Saturday, January 17 and Monday, January 19.

5. Bring Concerns about KPD to PARC Next Week

The Police Advisory and Review Committee (PARC) is a civilian oversight committee that audits the discipline process and the policies and procedures of the Knoxville Police Department (KPD).

The purpose is to strengthen the relationship between the citizens of the City of Knoxville and the KPD, to assure timely, fair and objective review of citizen complaints while protecting the individual rights of police officers, and to make recommendations concerning citizen complaints to the Chief of Police and to the Mayor.

By making sure citizen concerns are addressed by an independent body, PARC aims to improve the relationship between members of KPD and the citizens they serve.

6. Community Development Sets Jan. 27 Public Meeting

The City of Knoxville's Community Development Dept. will conduct a public meeting at 5:30 p.m. Tuesday, Jan. 27, at the John T. O'Connor Center, 611 Winona Avenue.

At the meeting, the department will:

- 1) Present information collected from its Citizen Participation and Consultation Process.
- 2) Present draft Priorities and Strategies to govern how federal funds will be allocated beginning in July 2015; and
- 3) Take comments from citizens.

Information presented at the meeting will be available online after Jan. 28 at www.cityofknoxville.org/development.

The citizen participation process is part of an overall effort to develop a five-year Consolidated Plan for program years 2015-2019. The plan will identify community needs and priorities, and outline how the City will spend anticipated federal funds through the U.S. Department of Housing and Urban Development (HUD) from these programs: Community Development Block Grants, HOME (affordable housing) and Emergency Solutions Grants (homeless services).
