#### **4. NAC Meets Wednesday**

The Neighborhood Advisory Council will meet from 4:30 p.m.-6 p.m. this coming Wednesday, Feb. 11, at the L.T. Ross/CAC building at 2247 Western Avenue.

Topics of discussion will include the upcoming neighborhood conference, a report to NAC on the Neighborhood Small Grants Program, and expiring terms of three seats on the NAC. Other topics may be covered. The meeting is open to the public.

#### **5. Are you a landlord? Are you a renter?**

Poorly weatherized houses and apartments are a headache for landlords and renters alike, but a group of local partners is working on ways to relieve the pain.

Poorly insulated living spaces --- little or no attic insulation, for example --- typically have high utility bills. For renters, the monthly budget can be wrecked by one month of high KUB charges. And many renters often face the tough choice of which expense to pay last: utilities, food or rent.

Landlords see the other side of the coin: Financially stressed tenants fall behind in rent payments, and living units with high energy costs are harder to keep rented.

Several local partners --- including CAC, KCDC, KUB and the City of Knoxville --- are working as a team to address the high cost of energy bills. To make sure they are working with an accurate picture of rental housing, they want to hear from landlords.

The survey is part of a community-wide effort to increase energy efficiency and encourage weatherization.

## **6. City Crews Switch Back to Brush Collection**

Crews from the City of Knoxville's Public Service Department are now collecting brush again following the closure of leaf season. Find the brush collection schedule for your neighborhood by calling 311 or 865-215-4311. See <http://www.cityofknoxville.org/solidwaste/brush.asp>.

Residents should place yard waste next to the street in an unobstructed area (away from water spigots, mailboxes and utility poles). Please keep brush separate from other trash. Brush and leaves should not be mixed.

In 2014, the city picked up 26,600 tons of brush and more than 6,000 tons of leaves. All organic materials that are collected are ground and recycled into mulch or boiler fuel by the City's contractor.

## **7. MPC Schedules Public Meetings for One Year Plan Updates**

The development services staff of the Metropolitan Planning Commission (MPC) is holding public meetings in February to review preliminary proposals for updating the City of Knoxville's One Year Plan and to gather input from citizens on their ideas for amending the plan.

This is important to neighborhood groups because the One Year Plan serves as the basis for zoning decisions made by MPC and City Council. The meeting for the South Sector occurred last week. Here are the dates for the public meetings aimed at other parts of the city:

\*\* North, East and Central sector updates: 6 p.m. Wednesday, February 11, New Harvest Community Center, 4775 New Harvest Lane.

\*\* West and Northwest sector updates: 6 p.m. Wednesday, Feb. 19, Room 31, Middlebrook Pike United Methodist Church, 7234 Middlebrook Pike.

The Knoxville City Charter requires that a One Year Plan be developed and adopted in order to tie zoning districts to the Comprehensive Plan for the community. The Charter also requires development of 15-year sector plans and a 5-year capital Improvement plan for policy and mid-range guidance for the One Year Plan.

After these public hearings, the One Year Plan will be considered by MPC on March 12, and City Council at two meetings in April.

## **8. Use New KUB Map Service to Check Out Large Projects**

KUB has launched a new online Construction Projects Map that will give customers easy access to information about large utility projects. To view the map, go to [www.kub.org](http://www.kub.org), click on “Maps” at the very top of the page, and then click on “Construction Projects Map.”

The online construction map includes projects scheduled to last two weeks or longer. It shows projects separated by utility type and identified by color-coded icons. Visitors to the map can click on the color-coded icons for details specific to each project.

This map shows KUB’s larger capital construction projects. Due to quick turnaround time, short duration utility projects and routine maintenance or repair activities are not shown on this map.
